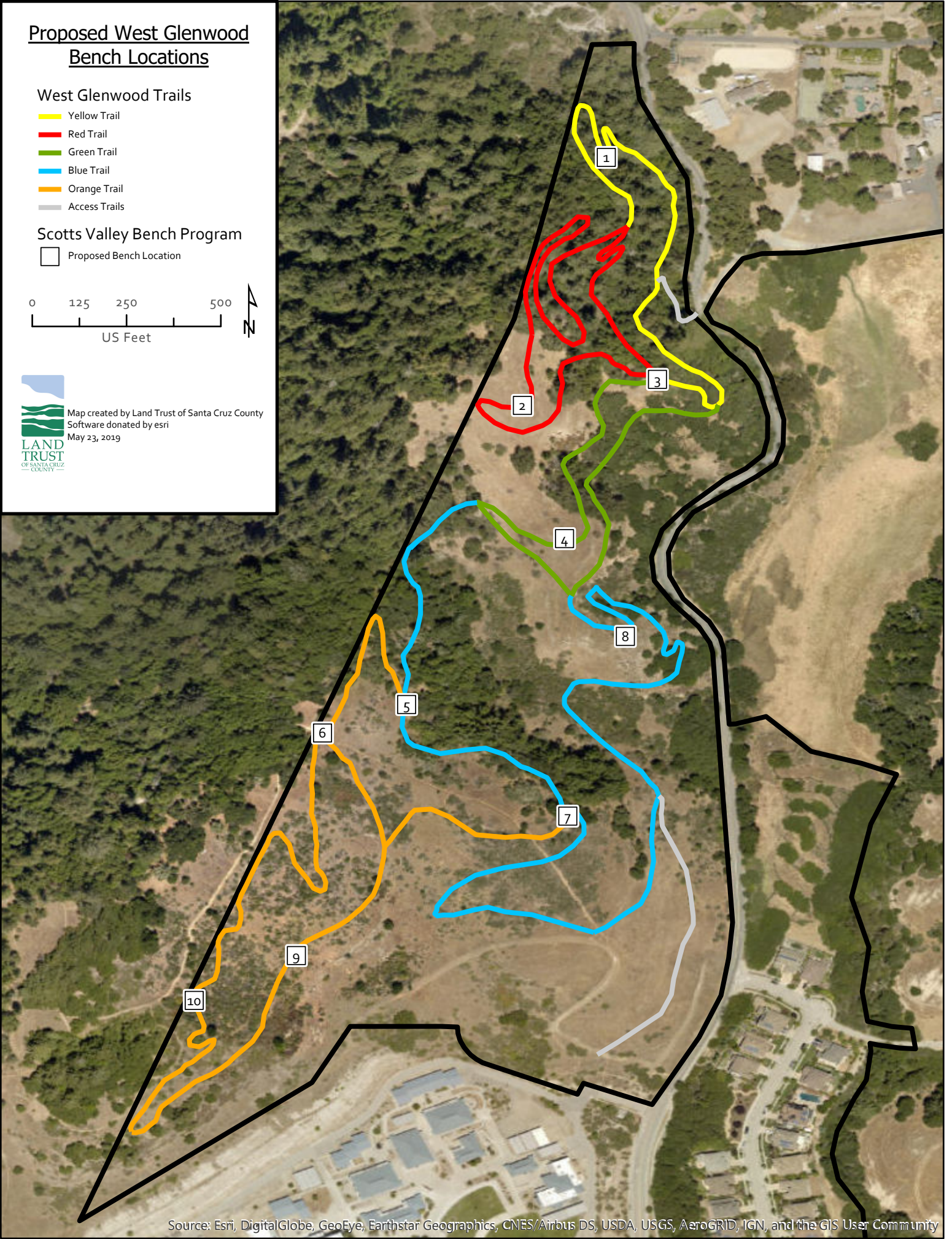
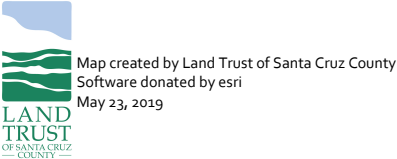
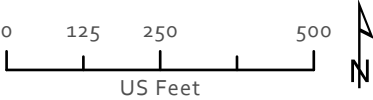
Proposed West Glenwood
